# To All Parishioners, Visitors, and Friends of St Mary's.

Parish of the R.C. Diocese of Aberdeen Charitable Trust. A Registered Scottish Charity No SC 005122

A recent review of our Parish Finances has shown that the situation is not as good as we would like it to be. Over the past few years in our General (No1 account) the income has been less than the expenditure, and with the overall increase in costs we need to address this issue.

Our end of year report for 2017/18, completed on the  $31^{st}$  March 2018, shows a Deficit of £6023

Most of our income is from the Sunday Collections, Direct Debit and Standing Order donations, Tax rebates from Gift Aid offerings, and the Small Gift Aid donation scheme. We also receive a monthly payment from the Diocese, for Clergy Support. We receive a small dividend from the Endowment Fund in respect of our investments. Occasionally we receive cash donations from Parishioners, and from visitors to St Mary's. Please consider the figures below.

This indicates a small increase in income, £353 for this year, which does not cover our present deficit.

Included in the Church and House expenses are the costs of Gas and Electricity. The Provisions for the house are a separate expense, and are kept low due to careful housekeeping.

Please note that Special Collections are not included as these monies are in our No2 a/c and are paid out soon after they are taken. Money collected for Fabric and repairs are held in the No2 account, and are ring fenced for these specific purposes.

Maintenance of our buildings is a constant source of expenditure.

#### HOW CAN YOU HELP?

- 1. **Gift Aid Contributors:-**Think about the amount that you give whether by Direct Debit, Standing Order, by your contribution to the Sunday collection by the use of Gift Aid envelopes.
- 2. Have you have ever thought to increase your giving? Like many things this needs a review to meet the increase in our expenditure?

- 3. Please consider signing-up to the Gift Aid Scheme. If you pay Taxes in the United Kingdom and you are in the Gift Aid Scheme this would give the Parish an extra 25% of your giving-paid by the UK Government.
- 4. If you are not eligible to sign up for the Gift Aid scheme, then consider an extra pound or two a week in the collection basket as you can afford.
- 5. We welcome suggestions for any other methods of increasing our income.

I am grateful to Carol MacLean, our Finance Secretary, and to the members of the Finance & Fabric Committee who have helped to manage our Parish finances. Perhaps you can help us to balance our books?

It could be that you are a visitor to St Mary's, a parishioner from elsewhere, or you have a connection with the Parish. If you can assist the regular parishioners in maintaining this Parish as a place of worship, open every day throughout the year, then we would be very grateful for your support.

To all who have read this letter 'Thank you' for your consideration of our situation.
